# INCIDENCE OF VEHICLE BORNE ATTACKS UNDERLINES VALUE OF PSSA

Berlin, Nice, London, Stockholm should be known as possible stop offs as part of a backpacker's European itinerary. As we now know, however, these are places now associated with vehicle borne attacks – or more precisely indicative of a rise in the use of vehicles as a weapon.

The PSSA fields enquiries from those responsible for security at public venues and corporate sites, who are anxious to get the best advice and source the right Hostile Vehicle Mitigation (HVM) products.

The PSSA values its relationship with the Centre for the Protection of National Infrastructure (CPNI), which provided a tailored training session for members and others earlier this year. ## **PSSA INPUT INTO INDUSTRIAL STRATEGY CONSULTATION**

Earlier this year the government published a Green Paper, Building an Industrial Strategy. Trade associations and companies were invited to respond with their thoughts on the key policy areas, or "pillars", that the government had identified as being fundamental to the success of the UK economy.

The PSSA provided its input via its membership of the UK's Security and **Resilience Industry Suppliers Community** (RISC). RISC is an inclusive alliance of trade associations and bodies which represent the UK's security and resilience sector.

The purpose of RISC is to act as an umbrella association in order to reduce the fragmented way in which the Government engages with the security and resilience sector, and to work with Government through the Home Office (Office for Security and Counter Terrorism) and other departments and agencies, on national security and resilience issues.

The RISC response included suggestions for priority areas for science, research and innovation investment, for what the UK can do to create an environment that supports the commercialisation of ideas, how innovation can be encouraged through public procurement and how government can improve its support for new and existing exporters.

The mesh pattern allows the fence to be raked, limiting the need for stepping panels across undulations in ground levels. The mesh still conforms to the high standard but reduces installation costs significantly compared with standard welded mesh systems.

## **Hostile Vehicle Mitigation Specialist Secures Greek Cultural Centre**

Award-winning security manufacturer, Heald Ltd, has completed the installation of its revolutionary surface mount sliding bollard solution, the HT2-Matador 3, at the Stavros Niarchos Foundation Cultural Centre in Athens.

The HT-2 Matador 3 was implemented on site, meeting the need for a surface-mount solution which would complement and blend in with the architectural design, whilst at the same time providing the highest level of security. The HT-2 Matador 3 has been tested to stop a 7.2-tonne truck travelling at 64 kph (40mph), whilst providing a zeropenetration rating and continuing to be fully operational afterwards.

because the venue hosts many significant, high-profile events, which are regularly attended by VIPs. An example of such an event was **President Obama's** speech at the SNFCC Opera, during his recent visit to Greece in November 2016.

## Middle East contract spawns Zaun flat-panel masterpiece

A massive Middle Eastern contract has given rise to a new flat-panel mesh security fence from PSSA member Zaun Limited.

Zaun has designed a variant of its original HiSec '358' welded mesh configuration with an extra wire every 250mm on the inside to enhance security and keep the panel flat without the need for rails or pressed V-beams.

The British manufacturer will ship a staggering 200-plus 40ft containers of the new HiSec Plus panels over the coming year to secure a Middle Eastern site of critical national infrastructure.

The first six containers have left the manufacturer's Wolverhampton headquarters with a further six set to leave before Easter.

The design department has offset the additional 4mm wires - setting quite a challenge to the production team - to enhance the security characteristics and make the single panel act almost like a dual skin fence.

"It's brilliant to see this new system coming off the production line as it's been more than four years in the making.

"The customer had a very clear specification of what they wanted, but we've been able to work with them over time to make enhancements and to reassure them at every step of the way on quality, design, production, sourcing and logistics."

The additional horizontal wires of HiSec Plus remove the typical bowing of traditional 358, while the 2.4m-high fence line is further secured with stainless steel razor coil topping and coated barbed wire as line wires.

The panels are bolted to 5mm-thick coldrolled steel posts, which are being welded to steel base plates at Zaun by a new robot welder bought specifically for the task, with each post and base plate a massive 75kg in dead weight.

The rolled steel is folded back on the front attack-prone flange of the post to create an effective 10mm thickness of steel. The post assemblies are then holted in the field to a continuous concrete beam.

The enhanced HiSec specification and fencing system cements Zaun's ability to deliver bespoke high-security fencing solutions.

Zaun's HiSec 358 is approved by NOMS for use in HM Prison Service where this mesh type is used prolifically due to its tight mesh

formation and the fact it can go to 5.2m in height in a single panel.

It can easily be integrated with different toppings, as in this case, and with CCTV, PIDs and other electronic security enhancements.

## **PSSA** Standards

## Are you aware and up to date with the General **Data Protection Regulation?**

It's less than 18 months until the General **Data Protection Regulation (GDPR)** goes into effect. Are you ready? If you're like most organisations, the answer is probably no.

But with 100% compliance required on May 25, 2018, and fines of up to 2-4% of global revenue for non-compliance, the pressure is on to comply.

Under the General Data Protection Regulation (GDPR), the data protection principles set out the main responsibilities for organisations.

The principles are similar to those in the Data Protection Agreement (DPA), with added detail at certain points and a new accountability requirement. The GDPR does not have principles relating to individuals' rights or overseas transfers of personal data - these are specifically addressed in separate articles (see GDPR Chapter III and Chapter V respectively).

The most significant addition is the accountability principle. The GDPR requires you to show how you comply with the principles – for example by documenting the decisions you take about a processing activity.

#### Article 5 of the GDPR requires that personal data shall be:

(a) processed lawfully, fairly and in a transparent manner in relation to individuals;

(b) collected for specified, explicit and legitimate purposes and not further processed in a manner that is incompatible with those purposes; further processing for archiving purposes in the public interest, scientific or historical research purposes or statistical purposes shall not be considered to be incompatible with the initial purposes;

(c) adequate, relevant and limited to what is necessary in relation to the purposes for which they are processed;

(d) accurate and, where necessary, kept up to date; every reasonable step must be taken to ensure that personal data that are inaccurate, having regard to the purposes for which they are processed, are erased or rectified without

(e) kept in a form which permits identification of data subjects for no longer than is necessary for the purposes for which the personal data are processed; personal data may be stored for longer periods insofar as the personal data will be processed solely for archiving purposes in the public interest, scientific or historical research

purposes or statistical purposes subject to implementation of the appropriate technical and organisational measures required by the GDPR in order to safeguard the rights and freedoms of individuals:

(f) processed in a manner that ensures appropriate security of the personal data, including protection against unauthorised or unlawful processing and against accidental loss, destruction or damage, using appropriate technical or organisational measures.

#### Article 5(2) requires that:

"the controller shall be responsible for, and be able to demonstrate, compliance with the principles."

## **PSSA** Legal Obligations

## THE MYSTEROIUS ISSUES **SURROUNDING CE MARKING**

CE Marking is mandatory for a wide variety of products including all electrical / electronic devices, allowing manufacturers to import and export their products freely within the European Union, with common product design and manufacturing requirements defined within EU Directives

By placing the mandatory conformity mark on a product, manufacturers (or if outside of the EU, the importer or authorised representative) are providing a clear indication that it meets all the relevant requirements and should therefore enjoy free movement between all 28 Member states.

#### **Problems with the CE Mark**

More recently Europe has witnessed an increasing number of products incorrectly marked with the CE Mark which have come onto the market from foreign countries. There are reasons for this which can be summarized

There has been a lot of confusion around the CE Mark itself with similar marks from China often confusing consumers and being mistaken for the genuine CE Mark.

It appears the CE Mark has been illegitimately placed on products which do not require the Mark, giving consumers the false impression that the product is one of

In its self, the CE Mark does not represent a product having undergone safety testing but more a self-declaration mark from the

manufacturer to allow the product's free movement across Europe. The CE Mark's aim is to provide a clear indication that a product meets the requirements of relevant CE marking directives and therefore should not be stopped at Member State borders

#### Who is responsible?

The CE Marking Directive requires manufacturers to be responsible for undertaking a full risk analysis, complying with essential requirements and ensuring that they can provide evidence of having carried out their responsibilities. If a harmonised standard applies to the product, the manufacturers have a duty to apply it. An additional duty the manufacturer will also now have is to determine if the standard is fully adequate for the product and its environment, or if the product requires further safety testing before being placed on the open market.

Whilst the vast majority of EU manufacturers are very thorough in ensuring they invest in meeting these standards, there has been criticism that manufacturers from a small number of EU member states have not been so rigorous. This has allowed cheaper, potentially unsafe products to enter the

#### How do you achieve Compliance?

Market surveillance authorities across the EU are addressing this area with more active policing of CE Marking. This will lead to a more robust level playing field for manufacturers across the whole of the EU and will make sure



that the CE Mark retains its status as a mark in which trust can be placed.

Achieving CE compliance can be a complex process due to the requirements of individual directives, particularly when combinations of directives apply simultaneously. So, to ensure you are compliant take time to carry out a health check looking at some of the following important areas:

Ensure you have your product Technical Files fully up to date with the correct published standards, regulations and codes of practice identified in standards Register.

Your Declarations of Conformity/ Incorporation are fully correct with the appropriate Standards listed and the correct published dates identified

Your sub-contractors/supply chain have met their responsibilities under the EU Directives particularly when it comes to supplying YOU with their Certificates of Conformity

Any testing conducted either in house or via a 3<sup>rd</sup> party is valid, and with the appropriate test certificates/test reports and conducted to the appropriate National/European/ International Standards.
